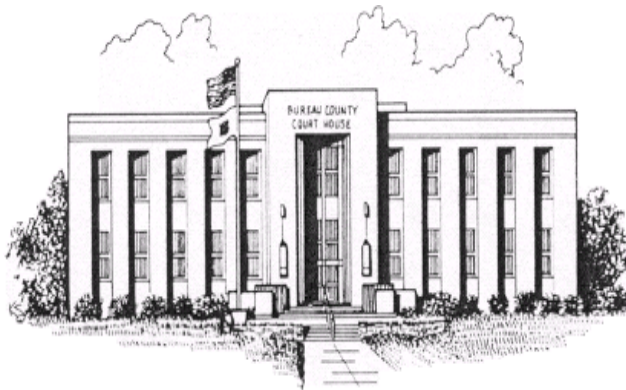

AUTHORITY FOR FEES

This schedule of fees is designed primarily to provide an outline of some of the fees that are required in civil and criminal cases. These fees are established by the Illinois General Assembly and the Bureau County Board. The Circuit Clerk is mandated to collect them.

1. Fees of the **Circuit Court Clerk** are authorized by State Statute 705 ILCS 105/27 et seq. and applicable Bureau County Board Resolutions.
2. Fees for **Court Services (Court Security)** are authorized by State Statute 55 ILCS 5/5-1103 and Bureau County Board Resolutions. The fee is dedicated to defraying court security expenses incurred by the sheriff in providing court services.
3. Fees for the **Law Library Fund** are authorized by State Statute 55 ILCS 5/5-39001 and a Bureau County Board resolution adopted and approved by the Bureau County Board on September 8, 2009. The fee is dedicated to the expense of maintaining the law library located within the courthouse. The law library is available to all licensed attorneys, judges, other public officers of the county and all members of the public, whenever the courthouse is open.
4. Fees for **Court Automation Fund** are authorized by State Statute 705 ILCS 105/27.3a.1 and Bureau County Board Resolutions. The fees are used to maintaining automated record keeping systems in the offices of the clerks of the circuit court.
5. Fees for **Document Storage Fund** are authorized by State Statute 705 ILCS 105/27.3c and Bureau County Board Resolution. The fee is used to defray the expense in establishing a document storage system and convert the records of the circuit court clerk to electronic or micrographic storage.
6. Fees to **Finance the Court System** are authorized by State Statute 55 ILCS 5/5-1101 (b) and Bureau County Board Resolution 93-43.
7. Fees for **Criminal & Traffic Surcharge Fund** are authorized by State Statute 730 ILCS 5/5-9-1 © and 50 ILCS 705/9.1.
8. Fees for the **Drivers Education Fund** are authorized by State Statute 625 ILCS 5/16-104a.
9. Fees for the **Violent Crime Victims Assistance Fund** are authorized by State Statute 725 ILCS 240/10(b).
10. Fees for **Trauma Center Fund** are authorized by State Statute 625 ILCS 5/16-104(b).
11. Fees for **Domestic Battery Fund** are authorized by State Statute 730 ILCS 5/5-9-1.6.
12. Fees for **Spinal Cord Trust Fund** are authorized by State Statute 705 ILCS 105/27.6 (b-1)
13. Fees for **DNA Offender Identification System Fund** are authorized by State Statute 730 ILCS 5/5-4-3 (j) and (k)
